The aim of the joint venture is to build up medical competence and expertise in the Kingdom of Thailand by founding the Swiss-Thai Medical Academy, driving forward specialist intercultural exchanges and enable the local manufacturing of high-tech medical solutions for orthopaedic surgeries and traumatology.

Demand for high-quality implants that were designed especially for large bones and the associated instruments is growing constantly.
